The Bosnia and Herzegovina/Federation of Bosnia and Herzegovina has received financing from the International Bank for Reconstruction and Development (IBRD) and European Investment Bank (EIB) toward the cost of the Federation Road Sector Modernization Project and intends to apply part of the proceeds toward payments under the contract for Installation of inclinometers and monitoring of tunnel Crnaja M-17. This contract will be financed by the World Bank. Bidding process will be governed by the World Bank's rules and procedures as National Competitive Bidding of qualified companies.

The JP Ceste Federacije BiH now invites interested companies to express their interest in provision of the following Services:

- Drilling of boreholes, depth approx. 80 m¹, using **rotary** technique with injection of inclinometer pipe with four longitudinal guides (total approx. 315m¹)
- Taking samples from the drill core, laboratory testing of samples, determination of particle size distribution and bulk specific gravity, Atterberg Limits, swelling test of samples with provision of engineering geological Study
- Monitoring Measurement by **inclinometer** in anticipated time periods with provision of studies regarding the performed measurements and tests.

Interested companies shall, along with the Application for Prequalification, submit information proving that they possess required qualifications, financial soundness, experience and personnel relevant for provision of the following Services:

- Organization and general experience of the Company: copy of registration and Company information: name, status, address, telephone number, facsimile number, email, year of establishment, contact person for the project, number of permanent staff and part-timers, fields of expertise;
- Financial soundness: audited balance sheets for the previous 3 (three) years to demonstrate soundness of Applicant's financial position and long-term profitability;
- Specific experience on similar assignments. Information of experience on similar assignments executed in previous 3 (three) years, including value and location(s) of the contract(s), number of personnel involved in the contract(s), name of the Client(s), name of the partner responsible for the execution of contract(s), source(s) of financing,

type of services provided, commencement and completion date of the contract(s), brief description of the contract(s). Minimum two successfully completed similar assignments in the previous 3 (three) years, with minimum value of BAM 100.000 each;

- Available or accessible equipment for rotary technique drilling, taking samples and laboratory testing, installation of inclinometers and measurements by inclinometer;
- Available or accessible competent expert personnel for execution of specified assignments, drilling of boreholes, installation of inclinometers, monitoring measurements by inclinometer and provision of geotechnical Study;
- List of ongoing assignments including commencement and completion dates and engaged personnel;
- Possession of valid licence for execution of geotechnical investigations and licence for geotechnical laboratory testing in Federation of Bosnia and Herzegovina shall be required from the successful bidder upon Contract signature.

Anticipated period for provision of Services is from November 2017 to March 2019.

Bidding will be conducted through the National Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011, revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
