

## **Invitation for Bids**

The Bosnia and Herzegovina/Federation of Bosnia and Herzegovina has received loans for financing from the International Bank for Reconstruction and Development (IBRD) and European Investment Bank (EIB) toward the cost of the Federation Road Sector Modernization Project and intends to apply part of the proceeds toward payments under the contracts for Reconstruction of the Tunnel Crnaja at main road M-17, section Konjic – Jablanica. This contract will be jointly financed by the European Investment Bank and the World Bank. Bidding process will be governed by the World Bank's rules and procedures as an International Competitive Bidding (ICB).

1. The JP Ceste Federacije BIH d.o.o., Sarajevo now invites sealed Bids from eligible Bidders for: Reconstruction of the Tunnel Crnaja at main road M-17, section Konjic - Jablanica

Anticipated period for reconstruction will be 340 days in the years 2018/2019.

Phase I: March 2018 - June 2018 (100 days)

- Reconstruction of the road at the tunnel approaches on both sides
- Reconstruction bridges at the tunnel approaches
- Upgrade of transformer stations and
- Works on all external drainage and other installations

## Phase II: October 2018 to May 2019 (240 days)

- Works on the reconstruction of the Tunnel
- Internal drainage of the tunnel
- Hydrant network
- Lighting and electrical installation
- Alarm system and Fires protection
- Security systems (radio, video, speaker and traffic signalization)
- 2. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011, revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.
