1. The Bosnia and Herzegovina/Federation of Bosnia and Herzegovina has applied for financing from the World Bank toward the cost of the Federation Road Sector Modernization Project and intends to apply part of the proceeds toward payments under the contracts for Construction of the Main Road M-17.3 Neum –Stolac Lot 1 & Lot 2. These contracts will be jointly financed by European Investment Bank and the World Bank. Bidding process will be governed by the World Bank's rules and procedures.

2. The JP Ceste Federacije BIHdoo now invites sealed Bids from eligible Bidders for:

Construction of the Main Road M-17.3 Neum – Stolac:

- Lot 1. Pavement of Road section Stari Neum Babin Do L=5,3 km, Construction Road Babin Do -Oštovac L= 1,7 km and Construction Tunnel Oštrovac L=190m1 and
- Lot 2. Construction of Road section Oštrovac Broćanac L= 5,0 km.

Construction period for any lot will be ten months in the year 2017.

3. Bidders may bid for one or both contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid

4. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011, revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on 14 November 2016 at 12:00 a.m. local time.
