The Bosnia and Herzegovina/Federation of Bosnia and Herzegovina has received loans for financing from the International Bank for Reconstruction and Development (IBRD) and European Investment Bank (EIB) toward the cost of the Federation Road Sector Modernization Project and intends to apply part of the proceeds toward payments under the contract for Construction of main road M-17.3 Neum – Stolac: Construction of road section Hutovo-Cerovica L=4.850m¹ and road section Cerovica-Stolovi L=5.000m¹ and reconstruction of access road towards settlement Hutovo.

This contract will be jointly financed by the European Investment Bank and the World Bank.

The JP Ceste Federacije BIH d.o.o. Sarajevo now invites sealed Bids from eligible Bidders for: Construction of road section Hutovo – Cerovica L=4.850m¹ and road section Cerovica-Stolovi L=5.000m¹ and reconstruction of access road towards settlement Hutovo.

- 1. Anticipated period for construction will be 14 months.
- 2. Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011, revised July 2014 ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on 28.4.2020 at 12:00 hours (noon) local time.
- 6. All bids must be accompanied by a Bid Security Guarantee in amount BAM 100 000 or equivalent in a freely convertible currency.
