Based on the requests of potential Bidders JP Ceste Federacije BiH is giving Amendment No: 1 on Contract Notice for Works for Completion on Main Road M-18, section Kladanj – Podpaklenik including Karaula Mountain Pass published on S172 05/09/2015 311744-2015.

Pursuant to Amendment No:1 Section III 2.3 Technical capacity and Section IV 3.4 Time limit for receipt of tenders or requests to participate and 3.8 Conditions for opening of tenders now read:

Section III: Legal, economic, financial and technical information

III.2.3) Technical capacity:

Information and formalities necessary for evaluating if the requirements are met:

- The Tenderer shall provide a statement confirming that they either possess or will obtain promptly, in the event that they are awarded the contract, Authorization for performing construction business (alignment, bridges) on the territory of Federation of B&H issued by the Federal Ministry of Physical Planning;
- Specific experience as Contractor or Management Contractor in at least two (2) similar successfully completed road construction contracts within last three (3) years with the value of at least BAM 10.000.000 (or equivalent) and at least one (1) successfully implemented contract for bridge construction with reinforced concrete slab structure made on site with minimum span of 20m and minimum length of 100m;
- Adequate equipment and personnel pursuant to Tenderer Document available for use on the Contract.

The Tenderer shall own, or have assured access to (through hire, lease, purchase agreement, availability of manufacturing equipment, or other means), the following key items of equipment in full working order, and must demonstrate that, based on known commitments, they will be available for use in the proposed contract. The Tenderer may also list alternative equipment which he would propose to use for the contract, together with an explanation of the proposal.
